### Summer 2020 Preparation


Due to the 5<sup>th</sup> Amended Declaration, ASCC remains CLOSED.

- 1<sup>st</sup> Session Teacher Education Courses Begin (50% Online; 50% Face-to-Face).




Teacher Education Computer Lab Set-up - Room 10

# Continuing Students / Continuing Education for Summer 2020 COVID - 19 Compliance

- June 15, 2020 Courses began for continuing students and continuing education programs;
- 50% courses offered online; 50% courses face-to-face, all courses have online component;
- Laboratory courses, practical courses, vocational- technical courses meet four-days a week;
- No more than eleven (11) courses meet at one given time;
- No classes held on Fridays;
- All face-to-face courses are required to meet social distancing restrictions.

  - Limited course offerings;
  - Decrease in revenue to ASCC;
  - New students must be trained and oriented to the College's online system;
  - Online payments most students do not have a credit card, use parents card;
  - Security of information for online services;
  - Stability of internet access;
  - Internet access to all students and all faculty;
  - Costs of internet access to students and to College personnel;
  - Accreditation standards particular to student contact hours. *Note: ASCC is not a certified online College to provide Distance and Correspondence education.*<sup>1</sup>
