ACCJC is undergoing the creation of a 2030 Strategic Plan. As part of that process, we are seeking the feedback of our member institutions, stakeholders, and the public. Our hope is to engage with faculty, staff, students, administrators, and the communities that they serve to chart a path forward for our work in promoting student success.

ACCJC's current [Strategic Plan](#) offers three key strategies and six primary objectives.

Key Strategies

- Strategy 1: Communicate and collaborate to advance the mission of ACCJC
- Strategy 2: Foster institutional innovation
- Strategy 3: Lead advocacy efforts on accreditation

Primary Objectives

- Objective 1: Support institutional efforts to increase student achievement
- Objective 2: Refine the comprehensive review process
- Objective 3: Develop a new accreditation standards framework
- Objective 4: Nurture ongoing collaborations and expand partnerships
- Objective 5: Strengthen ACCJC infrastructure and capacity
- Objective 6: Increase opportunities for two-way communication with member institutions
