President's Message

Dear Colleagues,



It is hard to believe that the year has nearly come to an end. The collective work taking place across our membership is transformative and worthy of a well-deserved and much-needed time of rest and reflection. As we close out the year ahead of a winter break, I am in Washington D.C., meeting with our colleagues in Congress who will play an important role in the year ahead. Highlighting the value of two-year institutions and their impact on communities was made easier by everything that you do – and by the work that we are all doing to better tell our story and to share the data that brings stakeholders from both sides of the aisle to our mission.

As I reflect on 2024, I am immensely proud of the work that ACCJC staff and volunteers have accomplished and grateful for the continued collaboration and relationship building with our member institutions and partners in the field. This year, ACCJC held its 2024 Partners in Excellence Conference, developed and launched its 2030 Strategic Plan, launched three major initiatives in collaboration with representatives from member institutions, continued to develop our Accreditation Platform, was awarded continued recognition by both the U.S. Department of Education and the Council for Higher Education Accreditation, enhanced our support for quality in distance education, and launched the Transparency, Storytelling, and Value Literacy Project. As part of these combined efforts, ACCJC hosted two of seven regional convenings where we engaged with institutional representatives on the topic of data, transparency, and communicating the value of two-year institutions of higher education. Across our expanding region, over 200 peer reviewers volunteered their time to serve on comprehensive peer review teams, including a visit to a rural community college in Arizona and a tribal institution in the desert of California. The work of peer review accreditation would not be possible without our volunteers' dedication and hard work. Finally, ACCJC is incredibly grateful to have been awarded a \$400,000 grant from College Futures Foundation to advance our Transparency, Storytelling, and Value Literacy Project and develop a Student Return on Investment (ROI) metric as discussed in the Navigating the Value Landscape for Accreditation white paper. The driving motivation behind all of this work is to highlight the value you bring to the students you all so passionately serve and to proudly share our outcomes as we advocate for our collective work. While I know these are challenging times for many reasons, we at ACCJC remain hopeful and inspired by all that you do on behalf of the over 2.5 million students you serve.

ACCJC Hosted the First Two Transparency, Storytelling, and Value Literacy Project Regional Convenings

ACCJC was delighted to gather with colleagues at Honolulu Community College and Riverside City College for the first two of seven scheduled regional convenings on data, transparency, and communicating the value of two-year institutions of higher education. Over 50 people joined us from institutions across the Pacific in October and almost 90 gathered at Riverside City College in November.

Space can accommodate **up to five attendees** from each member institution at a designated regional convening. We look forward to seeing many of you at those convenings next year!
