13.0202 Definitions

- (a) For the purposes of this Chapter, the definitions of "American Samoan" and "permanent resident" shall have the same meaning as in A.S.C.A. § 41.0202.
- (b) "Nonresident" means a person who is not either an "American Samoan" or a "permanent resident" as designated in A.S.C.A. § 41.0202.
- (c) "U.S. National" means "National of the United States" as defined in A.S.C.A. § 41.0202(1)(j).

- Tuition at the American Samoa Community College for each term, beginning the first term of the 1983–1984 college year, is as follows:
 - (1) American Samoans, U.S. nationals, permanent residents certified by the Immigration Board, and U.S. citizens: \$2 per credit, with a maximum of \$24 per term \$150.00 per credit for Associate level and \$215.00 for Bachelor level;
 - (2) All others residing in American Samoa under authorization of the Immigration Board: \$3 per credit, with a maximum of \$36 per term \$160.00 per credit for Associate level and \$215.00 for Bachelor level;
 - (3) Nonresident, non-U.S. citizens and nationals aliens upon authorization of the Immigration Board: \$4 per credit, with a maximum of \$48 per term \$160.00 per credit for Associate level and \$215.00 for Bachelor level.

- (5) Student activity fee: \$5-\$15.00;
- (6) Library fines: cost of replacement if not returned;
- (7) Breakage or lost equipment fee: cost of replacement;
- (8) Graduation fee: \$10 \$100.00 (plus \$25.00 for change of graduation date);
- (9) Official transcript fee: \$2 \$5.00 per copy, \$2.50 per student copy, \$50.00 Degree re-order or replacement per Degree.
- (10) Placement Testing Fees: \$10.00 for scheduled test, \$20.00 for late test, \$30.00 for unscheduled test.
- (11) Technology Fee: \$10.00 per credit for Associate level, \$16.00 for Bachelor level.
- (12) Other Fees:
 - (i) \$5.00 per credit for maintenance fees;
 - (ii) \$25,00 per course for administration fee.
